

**CITY OF BLOOMFIELD**

Mayor Rhonda Hagan invited all to say the *Pledge Allegiance to the Flag* and then called to order the regular monthly Bloomfield City Council meeting at 6:30 p.m. at the Bloomfield Fire House. Councilmembers present were Tracye Cheek, Donnie Holt, Denny Howard, Mark Mays, Walter Pozgay Tammy Wimpsett and City Attorney Amanda Blincoe. Kentucky Standard Reporter Jennifer Corbett was also present.

**MINUTES AND FINANCIAL REPORTS:** Council members were hand delivered a copy of the March 11th regular meeting minutes whereby the reading was waived. Wimpsett made motion, duly seconded by Howard, to approve the meeting minutes. *Motion carried by unanimous decision.* Next, Cheek made a motion, duly seconded by Mays, to approve the financial reports as presented. *Motion carried by unanimous decision.*

**CONCERNS OF THE PUBLIC**

Ed Gordon and Ernie Simpson spoke on behalf of Bloomfield American Legion Post #288 located at 243 Chaplin Road. They announced that their lounge is open six days from 4 to 9 p.m. and on Sunday from 2 to 7 p.m. They also hand out approximately 800 flags on Memorial Day and are planning a Golf Scramble. Their goal is to promote a good public perception of their organization.

Citizen Jim Glisson attended and spoke of the recycling bin overflowing each week.

**UNFINISHED BUSINESS**

**SAFE ROUTES TO SCHOOL CONSTRUCTION BID:** Pozgay made a motion, duly seconded by Wimpsett, to authorize Mayor Hagan to sign and execute the contract, pending Strand Engineer's and City Attorney's review, between the City of Bloomfield and United Construction & Design who had the apparent low bid of \$184,784.71 for the construction of approximately 4,000 feet of sidewalk on Arnold Lane. *Motion carried by unanimous decision.*

**CIVIC CENTER SOLD:** Mayor Hagan announced one bid was submitted for \$75,200 by Mark Ball of Taylorsville. She relayed that Attorney Blincoe is preparing a purchase agreement and it will be negotiated and signed Friday, April 12, 2013.

**MAYOR REPORT:** Mayor Hagan spoke of the many programs being planned at the Nelson County Bloomfield Branch Library. She presented the first draft of a "mission statement" for the City. She relayed an April 26 cancellation for "Music in the Park" series because of a baseball club schedule conflict.

**POLICE CHIEF DOWNS:** Chief Downs spoke of city patrols that have rendered citations, drug collections, complaints and disorderly conducts. He said progress was made to lower the speed zone on Chaplin Road to 35 MPH from the traffic light to past Arnold Lane to slow traffic in the business zone. He counted nine stop signs needed on city streets entering Taylorsville Road. Downs discussed the workers' compensation liability for a chaplain that volunteers on behalf of the city. Pozgay made a motion, duly seconded by Wimpsett, to work with this chaplain and pay the workers' compensation insurance based on his hours of exposure for the city. *Motion carried by unanimous decision.*

## NEW BUSINESS

**PUBLIC INPUT:** Hagan informed the Council of an information packet she is working on to explain the city's economic outlook to the public and invite them for input. She's offering a "Morning with the Mayor" at the Library on Saturday, April 20, 2013, from 9 to 11 a.m. to hear public comment, ideas, reflection, etc. She has scheduled a meeting with Nelson County Economic Development Director Kim Houston to help the City organize a plan to attract a grocery store chain to Bloomfield.

**DELINQUENT TAXES FOR 2012:** After reviewing the list of delinquent taxes (Exhibit A) consensus was to have Attorney Blincoe send letters requesting payment before action be taken to apply liens.

**FISCAL YEAR 2013-2014 BUDGET WORKSHOP:** A working session is planned for Monday, April 29, 2013 at 6:30 p.m. at City Hall for information gathering for the upcoming budget.

## CONCERNS OF THE COUNCIL

**Cheek** asked about the status of pavement damage that Mago was to address.

**Howard** discussed sump pumps located in city homes that direct condensation and ground water into the sewer lines and drains. He expressed concern that all sump pumps are to outlet into homeowner yards to defray infiltration into the new force main to Bardstown once it is connected.

**Mays** spoke of past discussions about a list of missing road signs and agriculture equipment traveling the roads this time of year.

**Pozgay** asked the officers about public parking on city sidewalks. He also asked if curb-side recycling is possible.

## ADJOURNMENT

Mays made motion, duly seconded by Howard, to adjourn at 7:15 p.m. *Motion carried by unanimous decision.*
